<u>Rules</u>

- 1. Age Limit: Players should be born on or after 1.1.2010
- 2. Two players in each category from every affiliated District Association of CAK.
- 3. Any other player who remits the prescribed Special Entry Fee of Rs.600/-
- 4. **Entries/Entry Fee** : All entries including special entries should come through the concerned affiliated District Association and all participants should be a registered player of the concerned affiliated district association.
- 5. Entry Fee Structure: Ordinary entry: Rs.300/- Special entry: Rs.600/-
- 6. Recommendation of District Association is mandatory for participation in the championship. Without District approval no player will be allowed to participate.
- 7. System of Play: The Championship will be played under FIDE's Laws of Chess and the Swiss system.
- 8. **Default Time** : Default time for arriving to the chessboard is 10 minutes.
- 9. Time control: 15 Minutes + 10 Seconds
- 10. **Tie Break**: Following is the order of tie-break:
 - 1) Direct encounter
 - 2) Buchholz Cut 1
 - 3) Buchholz
 - 4) Sonneborn Berger
 - 5) The greater number of wins (forfeit included)

In case of tie, cash prizes will not be shared.

11. **Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made In writing with a protest fee of Rs.500/- within 15 minutes of the occurrence of the

Incident .The protest fee will be refunded if the appeal is upheld.

- **12. Tournament Committee:** The organizers will form a tournament committee for the smooth conduct of the Championship
- **13. Interpretation**: For interpretation of the rule(s) and deciding any point not Covered by the above rules of the tournament, the decision of the Tournament

Committee shall be final and binding on all. The Tournament Committee has

Every right to make any addition or amendment to these rules, without prior

Notice. However, such changes/ or inclusion will be subject to CAK clearance.

Such changes will, however, be displayed in the tournament hall.

- **14.** Withdrawal: A Player may withdraw at any stage of the event only after informing the Chief Arbiter in writing.
- **15. Registration of Players with CAK:** All participants in the Championship should be registered with CAK for the year 2018.
