# RULES

1. Age Limit : Players should be born on or after 1.1.2005
2. Two players in each category from every affiliated District Association of CAK
3. Any other player who remits the prescribed Special Entry Fee of Rs.1000
4. Entries / Entry Fee : All entries including special entries should come through the concerned affiliated District Association.
5. Entry Fee Structure :  
Ordinary entry : 500/-                      Special entry : Rs. 1000/-
6. All entries including special entries should come through the concerned affiliated district Association on or before 19th May 2022 and all participants should be a registered player of the AICF.
7. System of Play : The Championship will be played under FIDE's Laws of Chess and the Swiss system.
8. Default Time : Default time for arriving to the chessboard is 15 minutes.
9. Time control : 40 Minutes + 5 Seconds.
10. Tie Break : Following is the order of tie-break:
  - 1) Buchholz Cut 1
  - 2) Buchholz
  - 3) Sonneborn Berger
  - 4) Direct encounter
  - 5) The greater number of wins (forfeit included)

In case of tie, cash prizes will not be shared.

11. Protest : Protest, if any, against the decision of the Chief Arbiter shall be made  
In writing with a protest fee of Rs.500/- within 15 minutes of the occurrence of the incident  
The protest fee will be refunded if the appeal is upheld.
12. Championship Committee : The organizers will form a Championship committee for the smooth conduct of the Championship
13. Interpretation : For Interpretation of the rule(s) and deciding any point not  
Covered by the above rules of the Championship, the decision of the  
Championship Committee shall be final and binding on all. The Championship  
Committee has every right to make any addition or amendment to these rules,  
without prior Notice. However, such changes / or inclusion will be subject to CAK clearance.  
Such changes will, however, be displayed in the tournament hall.
14. Withdrawal : A Player may withdraw at any stage of the event only after informing the Chief Arbiter in writing.
15. Registration of Players with AICF : All participants in the Championship should be registered with AICF for the year 2022-23

## Electronic Devices

In addition to the usual regulations for mobile phones and electronic devices, Players are forbidden to wear any kind of wrist watch. Players wearing watches Will be declared lost.
