RULES AND REGULATIONS

System of Play: The latest FIDE Rules in force shall apply and the SWISS system will be followed.

Tie Break: In case of a tie, the latest FIDE Rules shall come into effect. The Cash prizes wil not be shared.

Electronic Devices: All electronic items including wrist watches (all types of watches) will not be allowed in the tournament hall.

AICF Player Rgistration: 2023-24 AICF Registration is compulsory.

Existing Registration: For Existing players, please go to your player page in https://prs.aicf.in/players and click on extended membership.

New Registraton: https://prs.aicf.in/new-register

Protests - Protests, if any, against the decision of the Chief Arbiter shal be made in writing a protest fee of Rs. 1000/- within 15 minutes after the completion of the game to the committee. The protest fee will be refunded if the appeal is upheld.

Appeals Committee: Before the commencment of the Tournament, the appeals comittee comprising five members, wil be formed from the senior participants present in the player's meeting. The appeals committee's decison will be final and binding on all the players concerned.

Withdrawals: A player may withdraw at any stage of the event, after informing the chief arbiter in writing.

Players qualified for more than one prize wil be considered only for the higher prize.

Indian Income Tax Act and Rules will be applicable.

Attendance at the award ceremony is mandatory to receive the prize.

The entry fee will be refunded if informed prior to 7 days before the event date and is STRICTLY NON-REUNDABLE after that, as the organiser must make arrangments based on the registration.
